Thank you for participating in a Shannon Carson Wellness Event, which consists of a workshop, a class, an online workshop or class, a retreat or a series of classes or workshops, whichever is applicable (the "Workshop"), sponsored by Shannon Carson Wellness, and taught by Shannon Carson or one of Shannon Carson's designated co-teachers or volunteers (collectively, the "Teachers").

This Agreement, made between Registrant and Shannon Carson (Shannon Carson Wellness) and related individuals and companies, is as follows:

In consideration of and in order to be allowed to participate in any Shannon Carson Workshop, Registrant agrees as follows:

**Release and Waiver:** Registrant understands that Registrant will be participating in Shannon Carson Workshop, Registrant acknowledges that Shannon Carson has no way of determining Registrant's physical, emotional or mental health or fitness to attend the Shannon Carson Workshop, Therefore, Registrant agrees not to bring a lawsuit or any other action of any nature or make a claim for damages against Shannon Carson or anyone associated with producing the Shannon Carson Workshop. Participant understands and accepts that participation in the Workshop is strictly voluntary, at your own risk, and that you freely choose to participate. Since the Workshop is experiential and the extent of the Workshop's risks and benefits are not fully known, you agree to assume and accept full and complete responsibility for any known and unknown risks associated with your participation in the Workshop, including any physical injury, psychological or emotional effects, death, loss, or property damage.

**Nature of Workshop:** The information presented during the Workshop, including manuals, handouts, techniques, trainings, exercises, initiations, processes, activities, energetic therapies, downloads, instructions, ideas, suggestions, and other materials (collectively the "Materials"), is educational in nature and is provided only as general information and is not medical or psychological advice. Registrant understands the Workshop is experiential in nature and focuses solely on personal growth and spiritual transformation and is not to be considered treatment for any physical, emotional, or mental disorder.

**Acceptance of Risk:** Registrant understands that there are no guarantees that Registrant will be healed, benefitted or changed by taking the Shannon Carson Workshop, However, Registrant further understands that participating in a Shannon Carson Workshop may substantially change Registrant's life and circumstances and Registrant freely accepts and embraces that change, regardless of any effects, expected or unexpected, that such a life changing experience may create. Registrant agrees to consult with their health care providers for any specific medical, emotional, or psychological problems or issues in advance of the Workshop. Further Registrant agrees to take full responsibility for your self-care during the Workshop and after. By participating in the Workshop, emotional or physical sensations may surface which could be perceived as negative side effects and possibly cause psychological and/or physical discomfort. If Registrant experiences any distressing reactions by

participating in the Workshop, Registrant agrees to ask for help from Shannon Carson, or one of the other Teachers.

**Slip and fall or other torts:** Registrant acknowledges that the venue of the Shannon Carson Workshop is not owned or maintained by Shannon Carson or others associated with producing the Shannon Carson Workshop, Registrant waives any right to sue or seek damages for slip and fall or other physical torts which may occur at the Shannon Carson venue from Shannon Carson or others associated with producing the Shannon Carson Workshop. Should the venue be owned or maintained by Shannon Carson or a Teacher or volunteer, Registrant agrees to hold harmless Shannon Carson Wellness, Shannon Carson, the Teachers, volunteers, and any independent contractors from an damages or costs, including court and attorney's fees, which may be incurred due to Registrant's participation in the Workshop, and limit Registrant's recovery to the proceeds, if any, available under premises liability insurance policies owned by Shannon Carson, the Teacher or volunteer.

**Disclosures:** Registrant understands that Shannon Carson is not a licensed mental health professional, designated Teachers and volunteers may not be licensed mental health professionals, and Registrant is not seeking mental or emotional health counseling or help. Registrant represents that Registrant has no mental or emotional health disease or condition, which might be exacerbated by rigorous self-analysis, meditation or introspection. Violation of this provision shall subject the Registrant to litigation for injunctive relief and damages and Registrant irrevocably consents to the jurisdiction of the state and federal courts of New York City, New York for the purposes of any action brought for the violation of this provision.

**Binding on Heirs and Assigns, Minors:** Registrant agrees that these provisions shall be binding on Registrant, Registrant's family, heirs, assigns, legal representative, successors or any one claiming in, by or through me. If Registrant is a minor, Registrant represents that the person or person registering through this website has the authority to bind Registrant to the terms and obligations herein.

**Governing Law and Counterpart Signatures:** This waiver shall be governed by, and shall be construed in accordance with, the laws of the State of New York without giving effect to the conflict of laws principles thereof. Any lawsuit, action or proceeding arising out of or relating to this waiver may only be instituted in any federal or state court in the jurisdiction where Shannon Carson resides. Registrant hereby irrevocably submits to the jurisdiction of any such court in any suit, action or proceeding.

**Effect of Registration:** This waiver and release shall be deemed executed upon signing this Agreement by Registrant, or if registering online, upon registration by Registrant. By clicking on the acceptance box provided online, Registrant affirmatively agrees to the terms herein. If registering online, Registrant waives any necessity of signature or other affirmative consent to the terms hereof. This waiver and release constitutes the entire and final agreement between the parties and supersedes any prior oral or written agreements, discussions or understandings. This Agreement may not be modified in any respect except in writing describing the modification and signed by both parties.
